

Catherine E. Gavin

Making a difference in the lives of others is an integral part of Catherine Gavin's life. She has demonstrated this commitment with a career in the public sector for more than 35 years.

As the current Deputy County Administrator for Camden County Government, Cathy holds the highest-ranking non-elected position held by a woman in the county's government. She oversees various departments including Health and Human Services, Economic and Workforce Development, Children's Services and Community Development to name a few.

Prior to this position, Cathy was the Director of Camden County's Department of Health and Human Services for nine years. She established the Annual Camden County Women's Health Conference in March 2000, which has grown from 200 attendees at the first event to more than 2,000 last year. Cathy also played a key role in expanding the Parent-to-Parent Coalition in Camden County, a support group for those who have children suffering from drug and/or alcohol addiction, and advancing the annual countywide flu immunization program that now reaches more than 25,000 residents.

One of Cathy's greatest passions over the past five years has been her work on the mental health task force and Crisis Intervention Team (CIT).
Charged with finding alter-

natives for incarceration, the task force works closely with law enforcement and behavioral health services to place nonviolent offenders with mental illness into treatment instead of prison. The CIT pilot program is now expanded statewide. Cathy also takes tremendous pride in Camden County's supplement food program for women, infants and children, known as WIC, which she initiated and implemented in 1974.

Throughout her career, Cathy has viewed each new role as the next step in a progressive path. Her education in Foods and Nutrition at Immaculata College led to a dietetic internship at New York Hospital/Cornell Medical Center then a position as public health nutritionist in the Camden City and Camden County Health Divisions. Cathy sees her choice to take a management position as one of her most substantial professional decisions and did so with her well-known "can do" attitude.

Cathy has been recognized with many accolades over the years, including being named the Community Planning and Advocacy Council Human Service Leader of the Year in 2007. She also received the Girl Scout Women of Outstanding Achievement Award, YWCA Women of Achievement TWIN Award and Camden County Manager of the Year, to name a few.

But for Cathy, it is not just a career. Her commitment carries over to her personal efforts throughout the community. During her four years of work with the Rotary Club of Camden, NJ, Cathy has worked in the areas of literacy, Polio eradication and disaster relief. She will be named chapter president on July 1, 2010. Cathy is also active with the United Way, March of Dimes and American Red Cross.

Outside of work, Cathy enjoys spending time with her husband, family and friends. She is an avid sports fan from her days of playing basketball in school and is someone who also likes the outdoors, fashion, theatre and travel.

Whether she is a personal acquaintance or an unknown advocate for her constituents, Cathy's community commitment is visible everyday.

That same year, Alisa, her dear friend, Alison Miller, and a few other close friends, founded Tapestries of Hope. What started as an organization to support women who lost another significant woman in their lives soon evolved into a group specifically for women who are grieving the death of their moms or mother figures. The vision is to provide a supportive environment for women to express their grief and honor their mother through support groups, workshops and programs to maintain the mother/daughter bond and continue healing.

Her role as Manager of Physician Compliance provides access to the latest health-related information, resources and

speakers. At HYA, Deborah began the Women's Health Luncheon, which addresses topics such as breast cancer, osteoporosis and Alzheimer's disease.

As for her most notable accomplishment, Deborah looks to her role in the "Miracle on Clayton Avenue" and its efforts in giving personal care, food and toys to more than 400 families throughout Camden County. The partnership between HYA, the National Basketball Players Association and Feed The Children made sure that these families in need were not forgotten.

Deborah's dedication extends beyond HYA as well. She is a member of the Cherry Hill Board of Education Minority Achievement and Diversity committees and also supports the Real Men Cook Charities as well as her affiliation with Asbury United Methodist Church of Woodlynne, NJ. Deborah is also Region II Governor for the American College of Medical Coding Specialists overseeing seven states and the District of Columbia.

Born and raised in Cherry Hill, Deborah resides in the same 3rd generation home she grew up in with her son, sister and brother. Like her role model, Harriet Tubman, Deborah strongly believes in giving all you can and a little more without the desire for personal gain. Those who know her would have to agree.
